

## AGREEMENT BETWEEN DOCSFORVISA.COM AND APPLICANT

### 1. Services Provided by Docsforvisa.com

Docsforvisa offers the following services and products to assist with visa applications:

- Day-wise Travel Itinerary
- Dummy Flight Ticket
- Travel Insurance
- Hotel Booking
- Visa Application Forms

The Applicant agrees that all services provided by Docsforvisa are intended solely for visa application purposes and related documentation.

### 2. Fees and Payment Terms

- The fee for **full visa filing**, payable at the time of filing the visa application.
- **Payments for products** are **non-refundable** once the product or service has been delivered.
